

The STREAM (Cameroon) is a new network, borne out of the STREAM Network created out of a 4-day meeting held in Nairobi, Kenya, from 30 September to 3 October 2022, hosted by Positive Young Women Voices of Kenya. STREAM stands for *Stepping Stones Trainers Engaging with Activist Movements*. The Nairobi meeting brought together feminist women rights activists living with HIV from Argentina, Cameroon, India, Kenya, Tanzania, Uganda and Zimbabwe. They came together with the aim of seeking to uphold and maintain the SRHR of women and girls in all our communities in the context of HIV, irrespective of our HIV status.

STREAM also recognizes that violence against women, and children forms a key part of children's and Women's vulnerability both to acquiring HIV and to living with HIV, across the life span.

Together we resolved to join our diverse professional and lived experiences, knowledge, skills and passions together to create the STREAM Network Cameroon.

#### **OUR PURPOSE**

We came together as STREAM NETWORK to seek a common purpose in our work - to uphold and maintain the SRHR of women and girls especially in all our communities in the context of HIV, irrespective of our HIV status. We all recognize that violence against women (VAW), and violence against children (VAC), form a key part of children's and women's vulnerability both to acquiring HIV and to living with HIV, across the life span. We all recognize that Adverse Childhood Experiences (ACEs) often challenge an individual's physical, mental and economic health and well-being across their lifespan. We recognize that these ACEs often include violence against women and against children. We recognize that children who have experienced violence in their own lives often grow up to become recipients and/or perpetrators of violence in their adult lives, thereby perpetuating the challenges they have faced in subsequent generations.

Within our communities, we all recognize also how the vicious cycles of Violence Against Children (VAC) and Violence Against Women (and Girls) (VAW(G) are both causes as well as consequences of HIV. These slow down, reduce - and often prevent - women's and children's realization of their SRHR. These challenges conspire to form what we call a draining circle, illustrated (the left hand circle below). Instead, through this proposed work, we seek to form 'gaining circles' (the right hand circle below), to overcome VAC, VAWG and to uphold all our SRHR.

STREAM NETWORK Cameroon is a feminist activist's movement women-led, apolitical, nonprofit, non-sectarian, non-governmental organization headquartered in Bamenda in the North West Region of Cameroon since 2023. It is borne from the Nairobi Kenya Meeting of 2022. The STREAM Network is a new network created out of a 4-day meeting held in Nairobi, Kenya, from 30 September to 3 October 2022, hosted by Positive Young Women Voices. STREAM stands for *Stepping Stones Trainers Engaging with Activist Movements*.

We were motivated to be in Nairobi Kenya in order to contribute to the Global SDGs: 1. End poverty in all its forms everywhere; 3. Ensure healthy lives and promote well-being for all at all age; 5. Achieve gender equality and empower all women and girls; and the HIV National Strategic plan of Cameroon.

STREAM Cameroon is aimed at upholding sexual and reproductive health rights, stopping violence against women and children and creating good relationships between children and their caregivers in order to ease disclosure and stop violence on children and women.





# **3 PROGRAM DEVELOPMENT**

3.1 Program development will follow the STREAM Trainers manuals guided by the StSt trainers. This we will adopt a three phase approach

#### Phase one:

Conduct initial experiential adaptation workshop (s) to go through the existing manual together with experienced StSt trainers

Training will initially require in person expert training for at least 2 weeks

Virtual or at a distance support will be required over the year as we move on

## Phase two:

Evaluate how much adaptation may likely be needed for the Cameroon context. Then run an initial training of facilitators workshop based on that adaptation

# Phase three:

Run a pilot led by the Cameroonian facilitators with ongoing support from the (external) trainers, then see what next in addressing the priority needs and desires coming from the intended communities as described below

# Strategy:

Read manual for better understanding, with technical support from the StSt trainers. Conduct initial workshop with the StSt trainers. Evaluation
